

## **SIERRA CLOSES NON-BROKERED PRIVATE PLACEMENT**

**Surrey, British Columbia, April 11, 2022 - Sierra Grande Minerals Inc.** (the “Company” or “Sierra”) (CSE: SGRO) (OTC: SIERF) (FF: F91Q) announces that it has closed its non-brokered private placement (the “Financing”). The Company has raised C\$2,037,900 through the sale of 13,586,000 units at a price of C\$0.15 per unit (the “Unit”).

Each Unit consists of one common share in the equity of the Company and one common share purchase warrant (the “Warrant”). Each Warrant entitles the holder to purchase one additional common share of the Company at a price of C\$0.20 per common share for a period of three (3) years from the closing of the Financing. Warrants are subject to a C\$0.05 increase in the second and third years of the Warrant term. Warrants are further subject to an acceleration clause, whereby after the first year of the Warrant term, if the common shares of Sierra trade and close at C\$0.60 per common share or higher, the Company has the right to accelerate the Warrants for exercise within 30 days of an exercise notice.

Securities issued as a result of the Financing will be subject to a one (1) year hold period. The net proceeds received by the company from the offering are expected to be used for general working capital purposes.

Certain directors and officers of the Company acquired Units under the Financing and such participation is considered to be a related party transaction as defined under Multilateral Instrument 61-101 *Protection of Minority Security Holders in Special Transactions* (“MI 61-101”). The transaction will be exempt from the formal valuation and minority shareholder approval requirements of MI 61-101 if neither the fair market value of any securities issued to or the consideration paid by such persons will exceed 25% of the Company’s market capitalization.
